DECALRATORY AND INJUCTIVE RELEIF

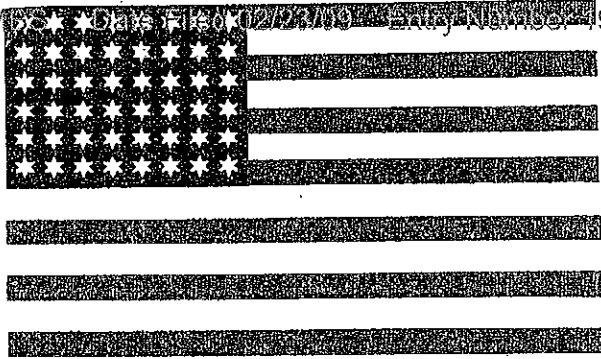

Therefore, any and all Administrative Federal, State, County or City Statutory laws, codes or enactment contrary to Constitutional Law Article 1, sec. 3 Constitution of South Carolina is invalid.
